Goodwill Temporary Services (GTS) employs individuals with disabilities and other barriers to workforce entry with part-time and full-time temporary jobs with federal and state agencies, municipalities and private businesses. During 2009, GTS provided 1316 regular services and also provided 740 employee assistance services. 569 individuals were placed in temporary positions within the community and 23 individuals obtained full time employment through their temporary placements.
